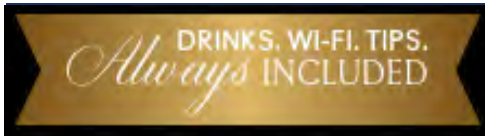

Steve has been an integral part of the Rockland County, New York, community for over 30 years, influenced by his parents, Ruth and Emanuel Gold, Holocaust survivors who owned the Gold and Rados egg farm and bungalow colony in the heart of the Catskills in South Fallsburg, NY, Steve has always been committed to community service and his Jewish heritage. He has served on the boards of the Rockland County Holocaust Museum and Study Center, New City Jewish Center, and JCC Rockland, where he was president from 2007 to 2013. During his tenure, he played a pivotal role in opening the new Jewish Community Campus. He co-chaired the 2012 JCC Maccabi Games opening ceremony and was instrumental in the global campaign for a minute of silence at the Olympics to honor the Israelis murdered at the 1972 Munich Games, which was recognized in Tokyo in 2021.

From 2017 to 2019, Steve's efforts to combat anti-Semitism through the Community Relations Council involved collaboration with diverse groups to foster understanding and tolerance. He also served as co-president of the Jewish Federation and Foundation of Rockland County from 2019 to 2024. In addition to his community work, Steve is the lead partner at **Peace of Stage**, a company that makes collectibles from the original Woodstock stage and runs **Yesteryearwear.com**, which celebrates the historical era of the Catskills.

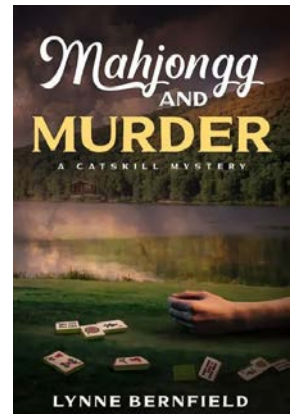
